Section 4. General Provisions

However, the Punong Barangay of the Barangay concerned may by ordinance or order be authorized to augment any item in the approved Annual Budget from savings in other item within the expenses class.

Section 5. Separability Clause. If, for any reason, any Section or provision if this Appropriation Ordinance is disallowed in the Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 6. Effectivity. The provisions of this Appropriation Ordinance shall take effect on January 1, 2020.
