APPROPRIATION ORDINANCE NO. 2 Series of 2019

AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF BARANGAY PAPALLASEN FISCAL YEAR 2020 IN THE TOTAL AMOUNT OF TWO MILLION SEVEN HUNDRED TWELVE THOUSAND THREE HUNDRED THIRTEEN PESOS ONLY (P2,712,313) AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

Be it ordained in Regular Session assembled:

Section I. The Annual Budget of Barangay Papallasen for Fiscal Year 2020 in this total amount of TWO MILLION SEVEN HUNDRED TWELVE THOUSAND THREE HUNDRED THIRTEEN PESOS ONLY (P 2,712,313.00) covering the various expenditures of the Barangay Government for FY 2020 is hereby approved.

Section 4. General Provisions

The appropriation herein authorized shall be strictly disbursed for the purpose for which they have been intended. However the Punong Barangay of the Sangguniang Barangay concerned may by ordinance or order, be authorized to the augment any item in the Approved Annual Budget from savings in other items with in the same expense class.

The Punong Barangay is hereby authorized to augment any item in the approved Amnual Budget from savings in other items within the same expense class of the appropriations in their respective offices, in accordance with Section 336 of the Local Government Code of 1991.

Section 5. Separability Clause. If, for any reason, any Section or provision if this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 6. Effectivity. The provisions of this Appropriation Ordinance shall take effect on January 1, 2020

ENACTED. This 15th day of October, 2019 at the Barangay Papallasen Multi-Purpose Hall, Papallasen, Burgos, Pangasinan.
